## INSURANCE WAIVER

### INTENT

**(1) THIS WAIVER AND RELEASE MUST BE PROVIDED TO THE CONFERENCE BY AN EXHIBITOR WHO, AFTER MAKING REASONABLE ATTEMPTS, IS NOT ABLE TO PROVIDE THE CONFERENCE WITH A CERTIFICATE OF INSURANCE AS PREVIOUSLY REQUESTED.**

**(2) AS SIGNATORY TO THIS WAIVER AND RELEASE, EXHIBITOR ASSUMES ALL RESPONSIBILITY FOR AND RELEASES FACSS FROM ALL CLAIMS AS DESCRIBED BELOW ARISING FROM THE EXHIBITOR’S PARTICIPATION IN THE CANNABIS SCIENCE CONFERENCE.**

### PREAMBLES

(1) CSC Events LLC is the sponsor, organizer and manager of an exposition of chemical and scientific equipment to be held from August 27-29, 2018 at the Oregon Convention Center.

(2) The Exhibitor has leased a booth(s) for the 2018 Cannabis Science Conference presented by CSC Events LLC from August 27-29.

### CONDITIONS
