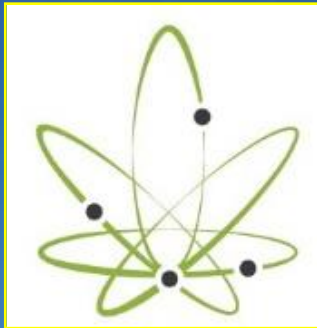


INSURANCE GUIDELINES & WAIVERS

INSURANCE WAIVER

THIS WAIVER AND RELEASE is made by _____ (“Exhibitor”) in favor of 2020 Cannabis Science Conference and CSC Events LLC.

INTENT

(1) THIS WAIVER AND RELEASE MUST BE PROVIDED TO THE CONFERENCE BY AN EXHIBITOR WHO, AFTER MAKING REASONABLE ATTEMPTS, IS NOT ABLE TO PROVIDE THE CONFERENCE WITH A CERTIFICATE OF INSURANCE AS PREVIOUSLY REQUESTED.

(2) AS SIGNATORY TO THIS WAIVER AND RELEASE, EXHIBITOR ASSUMES ALL RESPONSIBILITY FOR AND RELEASES FACSS FROM ALL CLAIMS AS DESCRIBED BELOW ARISING FROM THE EXHIBITOR’S PARTICIPATION IN THE CANNABIS SCIENCE CONFERENCE.

PREAMBLES

(1) CSC Events LLC is the sponsor, organizer and manager of an exposition of chemical and scientific equipment to be held from August 31 – September 2, 2020 at the Oregon Convention Center.

(2) The Exhibitor has leased a booth(s) for the 2020 Cannabis Science Conference West presented by CSC Events LLC from August 31 – September 2, 2020.

CONDITIONS

(1) Waiver and Release: The exhibitor assumes all responsibility for and all risk of any damage or injury whether to property or person, including death that may occur to the Exhibitor, its employees, agents, licensees, or invitees at or in connection with the event. The Exhibitor agrees to protect, save and hold CSC Events LLC, its Governing Board, Scientific Association Management, Oregon Convention Center, Fern Exhibition Services, and all agents and employees thereof (hereinafter collectively called Indemnities) forever harmless for any damage or charges imposed for violations of any law or ordinance, whether occasioned by the negligence of the exhibitors or those holding under the exhibitor, and further, the exhibitor shall, at all times, protect, indemnify, save and hold harmless the indemnities against and from any and all losses, costs, damages, liability or expenses (including attorney’s fees) arising from or out of or by reason of any accident or bodily injury or other occurrences to any person or persons, including the exhibitor, its agents, employees or business invitees, which arise from or out of or by reason of said exhibitor’s occupancy and use of the exhibition premises.

(2) Miscellaneous: Exhibitor understands and acknowledges that exhibitor may be waiving important legal rights by its execution of this form and exhibitor acknowledges that it has had an opportunity to review this form with counsel of its choice. The person executing this Waiver and Release on behalf of the exhibitor hereby confirms that he or she is authorized to do so.
